



# Thistle Communities Community Land Trust (CLT) Homeownership Program

## What is CLT homeownership?

The Thistle CLT has affordable ownership opportunities located throughout Boulder County. When a CLT home is initially sold, the land and the improvements are separated. The land is in the Thistle CLT, and the homebuyer owns the improvements. This partnership is guided by a 99-year renewable Land Lease, which has FannieMae and FHA approval. The homebuyer pays a nominal monthly fee (around \$35-\$50) to the CLT for land taxes and the administration of the program. To keep the home affordable over time, there is a price restriction when the CLT home is resold.

## How is a CLT home similar to a market-rate home?

A CLT home is subject to the whims of the real estate market. CLT owners have rights such as control over their environment, monthly payments and the ability to bequeath the home. CLT owners must maintain their homes, pay taxes on it, and may sell their home when they choose to.

### Program Criteria for Applicants:

- Be income and asset-qualified: (Complete the Boulder County Homeownership Programs Common Application and submit, along with supporting documents, to one of the participating agencies).

\* Depending on age (Under 40 - \$30,000; 40-55 - \$55,000; Over 55 years old - \$110,000) may be exempt if in Retirement accounts.

- Have a minimum of \$2000 available cash to go towards down payment and closing costs
- Attend a Thistle CLT Orientation prior to closing on a CLT home
- Take a CHFA (Colorado Housing and Finance Authority) approved Homebuyer Training Course (This class is available through Boulder County, or may be taken on-line by going to CHFA's website).
- Obtain a lender pre-qualification letter or pre-approval based on a tri-merge credit report for a mortgage loan (based on credit, income, savings, debt)
- Cannot own other residential property at time of purchase of CLT home
- Priority is given to households that meet the Thistle CLT minimum occupancy guidelines (for example, with a 3 bedroom home, priority is given if there are at least 2 people in your household)
- Priority is given to households that live or work in the city in which the property is located
